Mono Technology Public Company Limited (the “Company”) would like to submit the copy of 2014 financial report and financial statements for the year ended December 31, 2014 audited by the auditor and reviewed by the meeting of the Audit Committee No.1/2015 held on February 25, 2015. This financial report and financial statements were also approved by the meeting of the Board of Directors No. 1/2015 held on February 25, 2015, with details of operating results summarized as follows:

1. Total Revenues

The total revenues of the Company and subsidiaries for quarter 4/2014 amounted to 475.39 million Baht, compared with the total revenues of Q4/2013 amounting to 360.78 million Baht, increasing by 114.61 million Baht or 31.77 percent. The reason is that the revenue from mobile value added service in Q4/2014 increased by 21.47 percent, compared to 53.51 million Baht in Q4/2013.

The advertising revenue in Q4/2014, compared with Q4/2013, also increased by 67.23 million Baht or 116.44 percent, owing to the growth of revenue from TV Digital Business.

However, the total revenues of the Company and subsidiaries for the year of 2014 amounted to 1,603.43 million Baht, compared with the total revenues of 2013 amounting to 1,497.96 million Baht, increasing by 105.47 million Baht or 7.04 percent.

2. Net Profit

In 2014, the net profit of the Company and subsidiaries totaled 38.89 million Baht, compared with the net profit of 2013 totaling 501.12 million Baht, decreasing by 462.23 million Baht or 92.24 percent due to the commencement of the Digital TV Business and the accounting entry to record all actual costs on TV Business, namely, license fee, network service fee, content acquisition cost, utility expenses for supporting the digital TV business operation, including related public relations. However, the revenue from Digital TV Business was recognized in Q3/2014 and revenue growth increased in Q4/2014.
