Furthermore, in order to be consistent with the Notification of The Stock Exchange of Thailand Re: Rules, Conditions and Procedures Governing the Listing of Ordinary or Preference Shares Issued for Capital Increase, 2015 which has been enforced since May 16, 2015, the Company must inform the market price of the Company's shares over 7–15 consecutive trading days prior the first day of payment.

1. Four investors including investors No. 1, No. 2, No. 5, and No. 6 have paid capital increase by the amount above already. The payment was completed on January 12, 2017. Therefore, the Company scheduled the period to determine the price between December 20, 2016 to January 11, 2017 (which is the weighted average of the share price trading on The Stock Exchange of Thailand for not less than 7 consecutive trading days but not exceeding 15 consecutive trading days prior to the first day of payment). Since the offering price of 2.85 Baht is higher than 90 percent of the weighted average price which is the share price trading on The Stock Exchange of Thailand for not less than 7 consecutive trading days but not exceeding 15 consecutive trading days prior to the first day of payment between January 11-13, 2017, it is not the transaction that the offering price is lower than 90 percent of the market price according to the notification of The Stock Exchange of Thailand. Thus, there is no silent period.

Nevertheless, the Company specified six months of lock up period from the day when shares for capital increase was traded on the Stock Exchange of Thailand. This condition is above regulatory requirement of The Stock Exchange of Thailand.
